Formative scoping in mental health, rural Satara, Maharashtra – Summary of Dissemination Meeting (Hybrid Mode),

12th August 2024, Chhatrapati Shivaji Maharaj Sabhagruh, Zilla Parishad, Satara.

Dr Nerges Mistry, Director, FMR in her welcome speech outlined the Foundation's work in strengthening public health and its efforts in rural mental health care. She acknowledged the support received from various stakeholders for this scoping.

Dr Vasudeo Paralikar, Consultant and Head, Psychiatry Unit, KEM Hospital, Pune delivered the key note address focusing on the journey of mental health care in India to date. He emphasized a multidisciplinary approach to mental health care, moving beyond the 'treat and cure' model.

FMR researchers, Ms Vidula Purohit and Dr Shilpa Karvande, (PI) presented the scoping findings highlighting the need for capacity building, advocacy for drug supply, development of lay counselors, and culturally relevant mental health literacy strategies.

Personal stories from a **family caregiver** and **a community health officer** (**CHO**) underscored the challenges in mental health care, respectively emphasizing the need for a) better communication and support; and b) strengthening ongoing training of frontline health providers

- 3. Importance of understanding biological explanation of mental health disorders in better diagnosis and treatment (Dr Rokade)
- 4. Need for a small-step interventions for adolescents' positive mental health (Ms Patil)

- 5. Challenges in mental health care provision due to interrupted drug supply and gaps in training in DMHP (Dr Nayar)
- 6. Potential use of expertise and rapport of local community-based organization for future intervention (Dr Chedda)
- 7. Urgency for comprehensive mental health care at peripheral health facilities (Dr Khalipe).
